Being retired our hope, is to relax and let things take their course. That has not seemed to work out very well. Most of our members have relied on the Guardian from SPOG to stay current with not only the RSPOA but the department as well. However, the new leadership at SPOG has determined that



this is an old-fashioned means of communication—too slow and too expensive. At RSPOA we recognize that not everyone is computer literate or interested in online news sites. We also recognize that staying informed about the Guild and the Department is important to many members who dedicated their entire career to the Department.

Our answer is to renew publication of the Call Box and this is our first issue. Our plan is to publish every other month. Rich O'Neill has accepted the position as editor and Dick Rovig will be working with and assisting Rich in the process. Please note that editing and publishing a newsletter on a regular schedule is a challenging undertaking, so help them to do a good job by submitting articles and ideas.

Talk about change.

The last few months have seen dramatic change. We have all seen the city abandon the East Precinct and create a new state called CHOP. We have seen Seattle business looted and burned. We have seen citizens killed. With each new incident we see the City Council fail to act and to move to further limit the ability of the department to act. That culminated in the resignation of Chief Carmen Best. She really had no choice as the Council removed all the resources needed to confront the riots in

our streets. To double down, the Council cut the Chief's salary by over six figures—a planned and direct insult to Chief Best and her leadership.We do not know what will happen next. Actions of the Council have been decried nationwide. It is impossible to see how any qualified person would seek to be a new chief. It is impossible to understand why anyone would accept even the position of interim chief—at least not with any hope of maintaining their honor or meeting the obligations of the oath of office.

The council has backed down, but only a little. I guess we will see what the future brings. Right now, things do not look bright for Seattle.

Taking action.

The RSPOA has been investigating actions we might take to ensure the citizens of Seattle are fully aware of the dangerous road we are on with the efforts to defund the police department. Our current council and mayor are all recently elected with strong majorities. It is not likely we will see any major change. However, it is still possible to let the council know that the citizens of Seattle will not stand by and see this beautiful city destroyed.

The RSPOA has investigated engaging the services of a public relations firm to assist us in informing the public. Three former mayors have agreed to provide their thoughts and concerns about the direction of the current council. But the cost of an effective campaign far exceeds our available budget. We continue to seek out other options

It is time the citizens take the city back. The first thing we can do is to communicate with the mayor and council and demand that they enforce the law and prosecute those who violate the law. We simply cannot allow the criminal conduct of rioters to go unpunished. elected officials need to hear that we will no longer stand for it..

Relief Moves to the Range

Effective August 17, the Relief Association office on Eastlake Ave. E. has moved to the west side of the duplex at the SPAA Range in Tukwila. The SPRA mailbox will be inside the Range Office for both USPS and Inter-Department mail runs (<u>note that the</u> <u>Range Office is closed on Mondays and Tuesdays</u>).

After SPOG and SPRA sold the SPRAG office building on Eastlake in 2017 to a local developer, the Relief Association began to develop a plan to move which has resulted in a partnership with SPAA to build a new office building at the site of the current Range Office. The new building will house the current Range Office services, support SPRA's day-to-day business, and provide two training classrooms for SPD and other agencies to rent.

Though we don't have a current ground breaking date yet, the building plans are making their way through the city of Tukwila's building permit process (the change of use has already been approved by Tukwila).

Cynthia and Traci (SPRA staff) will continue to work remotely but will do mail pickup 1-2 times per week. Please continue to communicate with them via phone and email as well as processing supplemental health plan reimbursements electronically if possible.

The Publication That Won't Die

Acording to this 1967 edition, the Call Box was created in 1947 by the SPD Public Information unit as a mimeographed sheet designed to inform department members of general interest items and local gossip.

As the years went by, the publication was modernized and continued until 1969. SPD continued to print department news sporadically in various publications, such as the Seattle Police News and the SPD Journal last published in 1980. The advent



of the SPOG Guardian in 1971 spurred much of the energy in producing publications during that time. Probably, the discontinuance of a Department publication during the intervening years can be laid to that old municipal bugaboo, cost-effectiveness.

Even though the Guild was generously providing RSPOA members with the Guardian free of charge, the Association decided to publish a document to keep our group informed of ongoing information. After obtaining department permission to use the name, RSPOA Secretary Nick Bulpin became the editor of the RSPOA Call Box.

Once again, though, after a few issues, "cost-effectiveness" caused us to discontinue the publication. After all, the Guild was giving us all monthly space for all we needed in the Guardian.

Well, the Guardian is gone, a victim of technology and universal indifference to the printed page. Technology rules. Half our membership, though, don't have computers and apparently don't want one.

Consequently, we will be supplying you folks with Pension Office information including Last Ring, new retirements etc. We'll continue to track legislative news and all that other information we supplied you folks with in the Guardian in a bi-monthly Call Box.



PENSION OFFICE NEWS

Reporting Forms for 2021 will NOT be mailed out in our usual November time period. Due to the current pandemic situation, we will mail out the Medicare Reimbursement form only to those who are eligible, in November/December 2020. We are asking if you have the ability to scan and email this form back to us, to do so, you can also fax them (this form does not have to be notarized); last resort is the US Mail please. The Reporting process will change to late Spring 2021. Reminder - mandatory proof is required for any reimbursement of Medicare Part B above the standard rate of \$144.60 per month. Your proof is the letter that everyone receives from Social Security dated approximately November 2019 that say's what your 2020 Medicare Part B premium would be - hopefully put in your filing cabinet!

Notice of the NEW- UMR Self Submitted Reimbursement Form (this is for anything you have paid out of pocket that is Medically Necessary as prescribed by a Dr) is now being used. Please be sure to use this NEW UMR FORM, it will be mailed to you approximately Mid to Late August.

Please know any address/phone or POA changes can be sent to us via email at <u>policepension@seattle.gov</u> or to Stephanie at <u>stephanie.coleman@seattle.gov</u> please be sure to include your new full address, any new home landline number, any cell phone number as an alternate so we are able to reach you with any questions!

Due to Covid-19, the office continues to work remotely by order of the Mayor, Please do not plan to come in person to the Pension Office as we are working remotely until January 4, 2021 . Should you need to contact us, the fastest way is via email – Janice Brandes is at Janice.brandes@seattle.gov and Stephanie Coleman is <u>stephanie.coleman@seattle.gov</u> otherwise, continue to leave a voice mail as they are being checked multiple times a day. **Take good care of yourself' s and please stay safe!**

Just What is a Call Box, Anyway?



However, if you look back on how police talked to each other back 130 years ago, it brings to light just how far police communication technology has come." "In the municate with each other by blowing a whistle. They would blow it anytime they needed assistance from the public or other officers in the area." "By 1890, The Seattle Police Department went to the Gangrel call box system. The cast iron box was mounted on telephone poles throughout the city. The officers would open the box up and inside would be a police telegraph. When the officer needed to summon a patrol wagon to haul a prisoner or other assistance, he would bring the needle all the way over to the wagon signal and press down on the lever. This would send a telegraph signal to the Gamewell punch register. This machine would be located in police headquarters and the police clerk would be able to tell, based on the ticker tape punches, which call box was needing assistance." "By the 1930's police officers began driving cars. The only way they could communicate at that point and time was one-way communication over the public radio.
