City Medical Premium Reimbursements by Police Pension Due in June 2018 through November 2018

For the months June 2018 through November 2018, the Seattle Police Pension Office requests that its retired LEOFF I officers, NOW EMPLOYED IN OTHER CITY OF SEATTLE JOBS, and certain others, submit their written medical plan premium reimbursement request from June 2018 through November 2018 (6 months' worth). City of Seattle employer medical premium reimbursement will only be considered upon your written request, with supporting documentation, to the Police Pension Office.

The reimbursement rates for the <u>employee only</u> are as follows:

Seattle AETNA - Preventive = \$48.12/month Seattle AETNA - Traditional = no charge Group Health/Kaiser - Standard Plan = \$48.40/month Group Health/Kaiser - Deductible Plan = \$25.00/r onth

A very few retired LEOFF I members, who are insured through their spouses City of Seattle medical coverage and are enrolled through their spouse in one of the City's healthcare plans, are due a different reimbursement rate:

> Seattle AETNA - Preventive = \$50.38/month Seattle AETNA – Traditional = \$32.34/month Group Health/Kaiser – Standard Plan = \$51.50/month Group Health/Kaiser – Deductible Plan = \$31.92/month

ATTENTION S.P.O.G. MEMBERS:

For the calendar year 2006, and thereafter, sworn Seattle Police S.P.O.G. personnel now pay a portion (5%) of the City's cost of medical premiums for the two AETNA medical plans. The same reimbursement principal as previously described applies if the active duty S.P.O.G. member is covering a retired LEOFF I spouse.

For the <u>2nd half of 2018</u>, the following reimbursement rates apply: LEOFF I S.P.O.G. employee providing City medical coverage for a retired LEOFF I spouse/domestic partner:

Seattle AETNA Traditional Plan = \$50.00/month Seattle AETNA Preventative Plan = \$67.64/month

LEOFF II S.P.O.G. employee providing City medical coverage for a retired LEOFF I spouse:

Seattle AETNA Traditional Plan = \$60.22/month Seattle AETNA Preventative Plan = \$67.64/month

Proof of payment and proof of member costs are required:

For your <u>2018 – 2nd half</u> reimbursement, a copy of your spouse's <u>October or November</u> 2018 payroll stub is sufficient proof of payment.

Any retired LEOFF I members on Group Health medical coverage through an active duty S.P.O.G. LEOFF I or LEOFF II spouse needs to contact the Seattle Police Pension Office directly regarding reimbursement. These plans operate differently premium wise than the two AETNA plans.

Two things are required from the retired LEOFF I member, so eligible:

- <u>a letter (or memo)</u> from the retired LEOFF I member requesting reimbursement, <u>stating the plan in which they are enrolled</u> and the <u>monthly and cumulative amount of reimbursement</u>; including proof of retirees portion of premium, typically received from Human Resources.
- <u>proof of payment</u>; a copy of your <u>October or November 2018</u> City of Seattle payroll stub (or your spouse's payroll stub) is sufficient. Please redact (black out) all non-essential information. The Police Pension Office is only interested in who you are and the amount you are paying for medical coverage and the LEOFF I member's name who is receiving medical coverage.

Note: Reimbursement can only be made to the retired LEOFF I S.P.R.P.F. (Seattle Police Relief and Pension Fund) member so covered for medical benefits, not to a third party who would be providing that coverage as an offset.

Please submit your reimbursement request before the end of December 2018, if you are so entitled. Retired LEOFF I officers currently on other medical plans with outside employers, other than the City of Seattle, are requested to submit their reimbursement requests in December 2018, also. Proof of payment and proof of member costs are required.

All reimbursement requests timely presented will be paid during the month of May 2018.
